## IV. New Business

- A. Monitoring Report-Anna Krueger elaborated on her Monitoring Report that included the following:
  - Students will get ½ credit for HS English and 1 FVTC credit. Name of the course is "College Success."
  - Early graduation--1 of 3 has graduated early, other 2 students are working through some final details for early graduation.
  - Three students are enrolled in GED#2.
  - There has been a continuation of Wellness Speakers (included on monitoring report).
  - Eighteen students are currently employed, 4 students are in SAT (Student Advisory Team).
  - A volunteering update was given; discussion about St. Joseph's nursing home and Mosquito Hill.
  - Family Potluck will be on April 7 at 12:15 p.m.

A conversation occurred about increasing job opportunities, including discussion regarding Youth Apprenticeship, Work Release, and work hours to earn HS credits.

- B. Required Community Service Component--Brian Yerkey discussed an idea of potentially requiring community service hours for the future at Catalyst Academy (number of hours hasn't been discussed). This is a preliminary discussion about the idea of implementing the requirement. Mr. O' Brien suggested this may be successful if the students were either accompanied and/or graded for these community service hours. Brian elaborated that a current SEM project is putting together a website to connect community needs with student volunteers. Anna Krueger said this is something that could be introduced for the fall, so students were aware of the requirements up front.
- C. Jobs--Pat O-Brien said this topic was already discussed previously in Anna Krueger's monitoring report.
- D. 2020-21 Meeting Dates--it was discussed that the 2020-21 school year meeting dates would happen on the same pattern as this year: every other month, starting in August, meeting on the first Monday of each month.
