Shall the School District of New London, Waupaca, Outagamie and Winnebago Counties, Wisconsin be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$1,300,000 for the 2018-19 school year and for each of the succeeding 9 school years thereafter, for non-recurring purposes consisting of building maintenance and operations, energy efficiency projects, life safety and security improvements, and debt service for additional functional space at Parkview Elementary and capital improvement projects at all schools?

Estimated Tax Impact

On a **\$100,000** home there will be a **reduction of approximately \$150** per year (reduction due to debt retirement)

PROJECTED IMPACT

Home Value: \$100,000

	CURRENT	PROJECTED
School Tax:	\$916	\$766
APPROXIMATE TAX REDUCTION OF 16% OR \$150		
Tax Rate:	\$9.16	\$7.66

Estimates until October 15 when state certifies equalization aid. District is using July 1 estimate received from state.

 - maintenance

 - · safety/security
- An independent facility study affirmed millions of dollars of facility improvements
