### Chromebooks

All students will be able to keep their chromebooks through the summer to remain connected to the communication provided by the district and for access to summer or continued digital instruction/learning. At this time the Kajeet wireless devices will also be kept with families, however, data may be limited based on summer school enrollment. The [Technology Acceptable Use](#) policy is still in place, this device should continue to be used for educational purposes. If families do not need the device over the summer, please prepare it for summer storage: secure it in the protective case, put it in a safe location.

If families do not want students to have the device, or are leaving the district, moving etc. the device and charger should be returned to the District Office. ([Device Return Form](#))

**Although managed devices have some level of security, we strongly encourage families to establish safe routines and structure for any use of technology by children. You may want to limit use to times when they are supervised.**

All SDNL issued Chromebook devices needing repairs should be dropped off **with a charger** at the District Office during their summer business hours. (Please call the District Office at 920.982.8530 to arrange drop-off/pick-up of devices) Parents/students will be asked to fill out a repair form when they turn in the SDNL issued Chromebook device. Paper copies will be available at the District Office. | <b><u>Registration</u></b> | <p>All registration activities will take place <b>digitally only</b>; we will not be hosting registration in person. Student pictures will be taken during face to face instructional days. Families will receive further information in July and August. Please note the following dates:</p> <ul style="list-style-type: none"> <li>• July 20: Skyward on-line registration opening date; available through Skyward Family Access and all fees are able to be paid online using eFunds.</li> <li>• July 20 through August 12: Bilingual families will be invited for registration support by our Bilingual staff; families will be contacted for individual appointment times.</li> <li>• August 4-7: Free and Reduced Application support</li> <li>• <b>Critical Health Plans and Health Records will be very important this Fall.</b> These have been used for students with health alerts such as asthma, diabetes and seizure disorders among others. If you think your child may need a health plan next year, please work with your child's doctors early on in August to develop and adjust plans for students with critical health plans.
